The fastest way to apply for a director identification number (director ID) is online at <u>www.abrs.gov.au</u>. Only use this form if you cannot apply online.

To prevent delays in processing your application, make sure you answer all questions.

If we can confirm your details with our systems, we will issue you a director ID and provide you with the number in writing.



When completing this form

- Answer all questions, otherwise we may need to contact you for more information.
- Print clearly, using a black or dark blue pen only.

- Make sure you read the privacy statement and sign the declaration at the end of the form.
- Provide acceptable proof of identity documents see section D.
- Penalties apply for providing false or misleading information.

Section A: Tax file number

1 Do you have a tax file number (TFN)?



It is not an offence if you do not provide your TFN. However, providing your TFN in addition to the identity documents in Section D, will help us verify your identity. The Registrar is authorised by the *Corporations Act 2001* and/or the *Corporations (Aboriginal and Torres Strait Islander) Act 2006* to request your TFN.

Section B: Application requirements

You can apply for a director ID if you are:

- an eligible officer, or
- intend to become an eligible officer within 12 months after applying.

An eligible officer, is an appointed director or alternate director (acting in that capacity) of a company, body corporate that is a registered Australian body or registered foreign company, or an Aboriginal and Torres Strait Islander corporation.

The Registrar may make a determination that a particular person or class of persons are not eligible officers.

You should not apply for a director ID if you already have an active director ID, unless you have been directed to by the Registrar.

I am an eligible officer or intend to become an eligible officer within 12 months of my application

To be eligible to be a director, you must:

- be an individual,
- be at least 18 years of age; and
- not be disqualified from managing corporations unless your appointment is made with the permission of ASIC, ORIC, or with leave of the Court.

I acknowledge to be a director I must meet the requirements of the Corporations Act 2001 and/or the Corporations (Aboriginal and Torres Strait Islander) Act 2006

If you have previously applied for and been issued a director ID, and have been asked by the Registrar to reapply, enter your previously issued director ID here and continue to the next section.
